



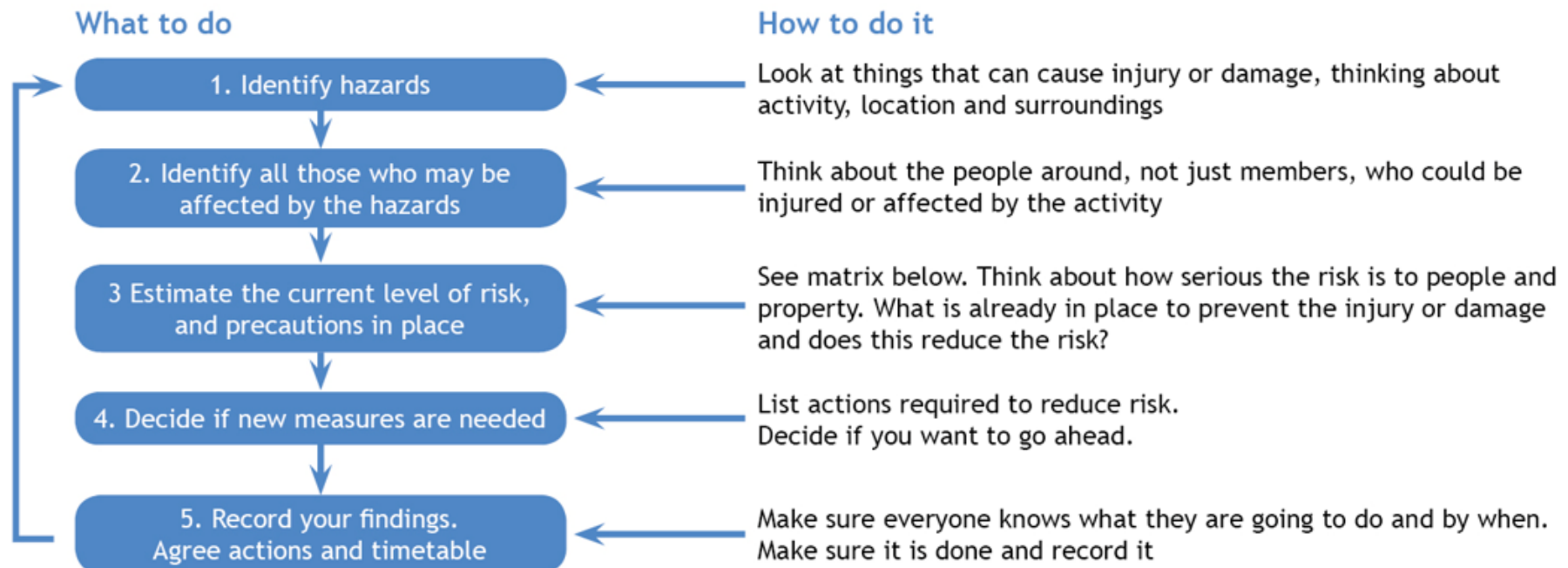

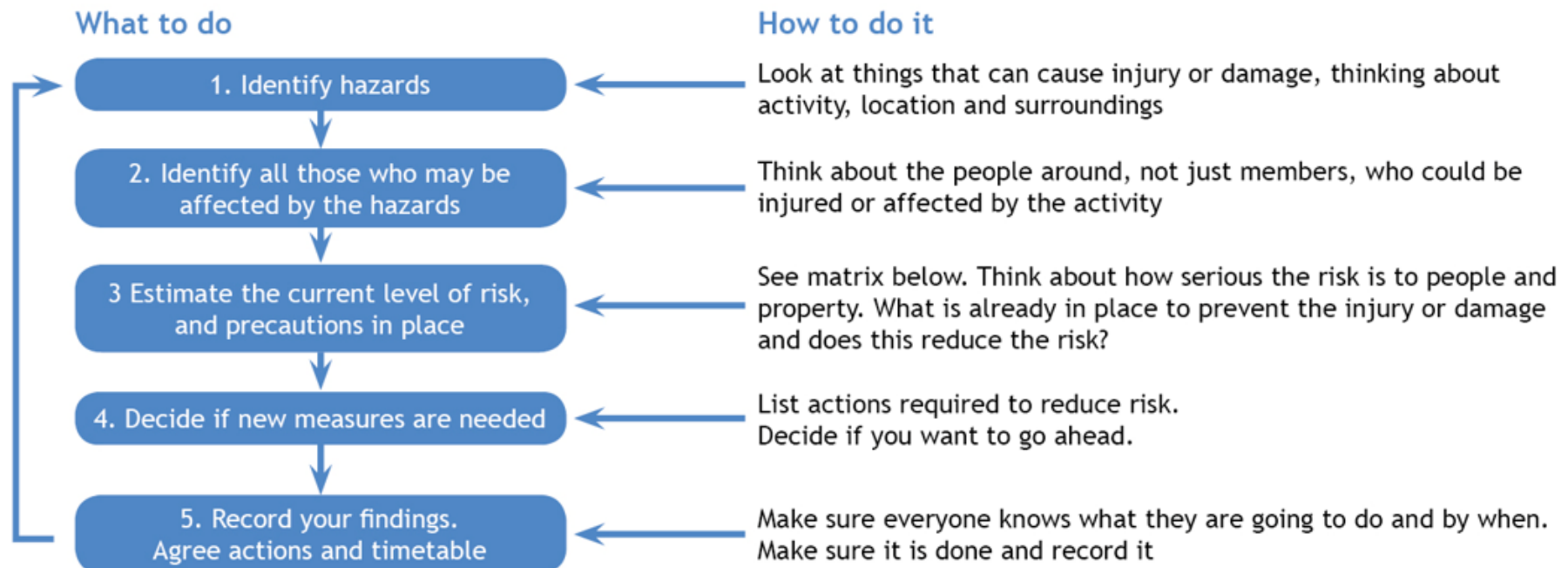

Fire (campfires, altar fires and patrol cooking area)	All - injury	<p>Altar fires positioned away from tents and hard shelters. Safe, unobstructed 2m space must be maintained around all fires.</p> <p>Fire buckets provided at all campfire/pitch areas. Groups informed they are responsible for filling them before lighting a fire.</p> <p>Groups informed they are responsible for extinguishing a fire at the end of a session/the evening. Water should be added slowly around the surrounding area and on the embers by an adult, taking care to avoid steam scalds.</p> <p>Campfires and backwoods-style cooking should only be held in their designated areas, and any dry materials (grass, etc.) cleared from the immediate vicinity.</p>	Low	Medium	<p>Fires should only be run by a competent person and must always be supervised by an adult.</p> <p>Visiting group is responsible for having a suitably qualified 1st aider and a 1st aid kit.</p>

Group leaders' mobiles may be charged to maintain communications as required, however girls devices should not use the electric sockets. Tripping over tent pegs/ guy ropes	All - injury	Groups should leave gaps between tents and maintain access routes for emergency vehicles. Whenever practical keep pegs in a straight line. Water hazards	All - injury from slips All - disease from waste water	Regular maintenance checks are carried out and repairs carried out promptly or unsafe areas marked as temporarily closed until fixed. Groups should report any leaks or blockages to the on site warden immediately.	Low	Medium	Groups should fill large water containers from the drinking water taps and then fill smaller, individual bottles from these to prevent ground flooding around the tap area. Toilets & wash facilities	All - spread of infection/ disease	Wash facilities are shared with other centre users. Lidded rubbish and recycling containers provided in the main gate entrance. Groups responsible for removing all belongings, including rubbish and litter, from their camping area before departure.	Low	Low	Group leaders to ensure bin lids are closed after use. Adults from the group must supervise young people at all times. Recycling to be clean before depositing in appropriate containers.	Group leaders - throughout their camp
Ticks	All - illness from Lyme disease	Group leaders informed that Dudsbury is known for ticks, particularly in the long grass.	Low	Medium	Group leaders advised to carry a tick remover in their first aid kits and to avoid the long grass areas. They should wear long trousers tucked into socks if entering long grass areas is unavoidable. Group leaders to be aware of the signs of Lyme disease and to inform parents/carers of young visitors to be vigilant after a visit to the centre. Do not pitch tents or sleep under trees Be alert to bad weather forecasts and move away from trees if high winds are predicted. Chemicals	All - injury, ingestion	All chemicals on site have COSHH documentation where relevant and are locked away. They are used by adults and training is given where relevant.
